Are you looking to attain your Minnesota Special Engineering Boiler’s License? This course will assist in preparing you to pass the licensure exam.

This course is designed for individuals who would like a Special Boilers License. This Preparatory class is designed to aid persons in taking the Minnesota Special Engineer License Exam. (Contact Minnesota Department of Labor & Industry, Code Administration and Inspection Services for exam information, location and times). Subjects covered will include boiler safety, operation, fittings, accessories and Minnesota Boiler Code as it pertains to the Special Engineer License.
